# Route Review Program Requirements

### Jurisdictions must:

- ✓ Review every route every year (68 Routes)
- ✓ Assess container contamination of prohibited contaminants
- ✓ Alert generators if prohibited contaminants are observed
- ✓ Report findings to CalRecycle in the Electronic Annual Report



## **RFP Process & Results**

- RFP sent to six firms
- One response: a team of two firms
- SCS/Envirolutions
  - Assisted with the Protocol and Pilot
  - Working relationship with Republic Services
  - Familiarity with Recyclist Software & service area
  - Technical Assistance experts



## **Route Review Plan**

## **Account Selection**

- Routes are set by Republic Services
- Accounts per route range from 200 1100 depending on size of collection vehicle
- Jurisdictions determine how many accounts per route shall be reviewed
- 25 accounts per route is based on an SB 1383 approved alternative contamination assessment approach which requires 25 samples per route.

## **Route Review Coordination**

- Coordinate with Republic Services to identify accounts for each route
- Inform Member Agency staff and authorities about route review timing and location
- Newest RES and COM Service guides + website includes info. alerting generators
- No photos
- If resistance is encountered, move on

## Follow up and Findings

- "Oops tags" and "Great Job" tags for residents/small businesses
- emails/phone calls for large commercial/MF
- Data Analysis
- Identify hot spots for targeted follow up
- Preparation of information for annual reporting to CalRecycle
