According to recent data from the state, construction and demolition (C&D) debris makes up about one quarter of landfilled materials. In an effort to meet state mandated waste diversion goals, we need to reuse and recycle more C&D debris!

Reporting Requirements & Green Halo

Reporting requirements for C&D debris diversion are established by the local C&D Ordinance or building code. **The minimum diversion rate is 65% and must be accomplished for all projects, both building and demolition.**

 **greenhalo** Tracking your project's diversion is made much easier by using the Green Halo online system which provides convenient reporting of disposal weight, receipts, and final project diversion calculation. Responsible Party

The primary responsibility for meeting the diversion requirement falls on the project's general contractor or the property owner (or whomever applies for the building permit).

C&D Debris Hauling

Property owners and contractors can self-haul their waste to a Certified C&D Processing Facility, however, if not self-hauling, only RecycleSmart permitted transporters/haulers may be paid to transport C&D debris from a project. A current list of transporters can be found on Green Halo. **Use of non-permitted transporters, when not self-hauling waste, is prohibited.**



Certified C&D Processing Facilities

Only RecycleSmart Certified C&D Processing Facilities may be used. Refer to the facility list on Green Halo. You must include disposal receipts/tickets for all debris loads, whether recycled or landfilled. **Use of a non-certified facility is prohibited and weight receipts from non-certified facilities will be counted towards landfill.**

Record & Track Your Project's Diversion

The final step in using Green Halo is an electronically submitted Waste Management Plan, which is required to document project diversion and complete building permit requirements.
