- No Special Rate Adjustment for Rate Year 10
- Future Special Rate Adjustments
 - Rate Year 11 = \$1,986,829
 - Rate Year 12 = \$1,986,826
 - Only if Service Quality Metrics are met
 - Per year not cumulative
 - In addition to annual index-based rate adjustments
- CCCSWA Executive Director has the authority to set new Service Quality Metrics
 - Meet and confer with Republic
 - Audit of phone call records
