Rate Adjustment Method

- RY 9 rates were adjusted using the costbased method
- RY 10 RY 12 are adjusted using the indexbased method
- RY 11 begins March 1, 2025
- RY 12 is the last year of this franchise agreement

Republic Services' Compensation

- Republic Services' compensation = Approximately 75% of the rates
- RY 11 index-based adjustment to Republic Services' Compensation = 3.34%
- Special Rate Adjustment = 2.53%
- Total change in Republic Services' compensation = 5.87%



Special Rate Adjustment

- Service quality metric = 2,700 or fewer missed container pickups from residential subscribers on incomplete routes in a four-week period
- For each period in which the metric is met, Republic is entitled to a special rate increase of \$283,833
- For RY 11 the increase will be either \$1,135,332 or \$1,419,165

Other Rate Components

- Other rate components = Approximately 25% of the rates
- Member agency fees
- Payment to MDRR for recyclables processing
- JPA administrative costs
- Payment to MDRR for the reuse program



Total Estimated Increase

- Estimated average rate increase, Republic + other rate components = 5.4%
- Increase will vary by Member Agency
- Member Agencies may utilize reserves to smooth rate increases
 - Reduce reserves to offset rate increases
 - Build reserves to offset future rate increases
- Next step = Individual meetings with Member Agencies
